I. Call to Order

The Chairman of the Board of Trustees, also the President of CARD Mutual Benefit Association, Inc., Ms. Deneglen C. Peñaflorida, called the meeting to order at 9:00 a.m.

II. Proof of Notice of the Meeting

The Corporate Secretary, Atty. Jomer H. Aquino certified that the Notice of Annual General Membership Meeting was issued on August 8, 2025, through publication on the CARD MBA website and by serving notice, along with the proxy forms, individually to the members through the Provincial Offices.

III. Proof of Quorum

The Corporate Secretary, Atty. Jomer H. Aquino determined the number of attendees, whether in person or by proxy. Out of 4,579,038 voting members, 3,797,777 proxy votes were gathered, and 12 voting members were present in person, representing 82.94% of the total. Hence, the meeting was formally started.



IV. Reading and Approval of the 2024 Annual General Membership Meeting Minutes held on September 9, 2024.

The meeting proceeded with the reading and review of the Minutes of the previous Annual General Meeting held on September 9, 2024. The President's request for approval was followed by a subsequent motion from Ms. Liezel J. Macoco, seconded by Ms. Babylita C. Mernilo. Therefore, the minutes of the 2024 AGMM were approved.

VIII. Election of the Board of Trustees

The election of the Board of Trustees was conducted in the presence of an independent Election Committee composed of Atty. Virlynn Rose R. Ramirez as the Chairperson, Corporate Lawyer, Atty. Anatalia Buenaventura and Deputy Director for Audit Ms. Kathleen Joy Almazan.

a. Nomination and Selection Procedures

The Election Committee Chairperson, Atty. Virlynn Rose Ramirez presented the election guidelines and procedures provided under the CARD MBA By-Laws.

As stated therein, there are two classes of members: voting and non-voting. Voting members are required to attend the regular center meetings of the partner institutions of the CARD MBA, while non-voting members are those who are not required to attend the regular center meetings. Voting members can vote through proxy.

The Board of Trustees is composed of fifteen (15) members, twelve (12) of whom are members of the association, and three (3) are Independent Trustees. Atty. Virlynn discussed the qualifications to be elected as a trustee. Virlynn Rose Ramirez, as follows:

- 1. Must be from the group of a female member of the CARD MBA;
- 2. Must be eighteen (18) to sixty-five (65) years old;
- 3. Must possess leadership skills and competence necessary to execute the duties of a Trustee;
- 4. Be an active MBA Coordinator for at least one year at the time of her nomination as a Board of Trustees member, and whose term is not expiring on the date of election;
- 5. A recognized active beneficiary member of the Center for Agriculture and Rural Development (CARD) Mutual Benefit Association, Inc., or any of its affiliates for at least five (5) years;



- 6. Has consistently performed very satisfactorily as a member of CARD MBA's affiliated institutions with a 100% repayment rate and at least 90% attendance rate in the center meeting for at least three (3) years;
- 7. Has ongoing business/es funded by a loan from any of CARD MBA's affiliates;
- 8. Has no conflict of interest or is not engaged in any business or activity similar to or in competition with the business of or services offered by CARD MBA or any of its affiliates, except for the business of or services offered by CARD Business Development Service Foundation, Inc.;
- 9. Has no pending administrative, civil, or criminal case; and
- 10. Willing to perform the functions of a trustee without any remuneration.

All qualified nominees underwent a thorough background check by the Regional Committee (RC), which met on April 25, 2025, to ensure that all nominees for the new Board of Trustees were eligible and met the set qualifications of a Trustee. The Regional Committee then endorsed the list of nominees to the Central Nomination Committee (CNC), which meets on May 13, 2025, and was headed by Mr. Rolando A. Robles, and is composed of other independent parties for final scrutiny, during the actual election at AGMM, an external independent Election Committee headed by Atty. Virlynn Ramirez supervises and validates the whole election process.

Based on the results of the RC and CNC meetings held before the AGMM, ten (10) nominees will be elected on the AGMM for the vacant position, namely:

Atty. Virlynn Rose Ramirez reminded the nominees and the Board of Trustees to vote wisely and avoid single-voting. As a rule of the election, if the wrong number of proxy votes is indicated in the election form, the said vote will be considered one count. Further, she discussed that the election will be online. The votes will be automatically tabulated, and the results will be flashed on the monitor in real-time for the participants to see.



The election for this year used Office 365 Forms as an online application for the election form.

b. Election of Board of Trustees

After the explanation of the whole process of nomination, the election started, and all nominees and the Board of Trustees were called to access the given online election form.

The entire election process was conducted under the close supervision of the Election Committee and lasted approximately two hours. Under the presence of the nominees, members, and guests who attended, the automatic tabulation through online electronic voting was flashed on the monitor. The Election Committee Chairperson announced the number of votes cast for each nominee.
